



## **Parent-Teen Driving Agreement**

By initialing each item, both parties acknowledge the rules and promises stated in this contract.

### **Parent Responsibilities**

#### 1. Leading by Example

\_\_\_\_ \_\_\_\_ I promise to teach my teen driver, responsible and safe driving by example.

\_\_\_\_ \_\_\_\_ I promise to provide attentive supervision and constructive feedback throughout my teen's driver training.

\_\_\_\_ \_\_\_\_ I will support my teen's driver training experience with an encouraging and patient attitude.

#### 2. Teen's Safety First

\_\_\_\_ \_\_\_\_ I promise to pick up my teen from any situation involving alcohol or drugs, or that makes my teen feel unsafe in any way, without question. I will not inflict punishment or judgment based on this type of incident.

\_\_\_\_ \_\_\_\_ I will always listen to my teen when he/she experiences frustration or difficulty with driver training tactics.

### **Teen Driver Responsibilities**

#### 1. Common Courtesy

\_\_\_\_ \_\_\_\_ I promise to respect and abide the rules set by my parent when driving at all times.

\_\_\_\_ \_\_\_\_ I promise to drive with respect for my fellow drivers and pedestrians by allowing others the right of way when I'm in doubt, and remaining patient towards other's needs.

\_\_\_\_ \_\_\_\_ I will always place my safety and the safety of others ahead of *any* other circumstances.

2. Driving is a Privilege

\_\_\_\_ \_\_\_\_ I understand that driving is a privilege, not a right, and I will treat it as such.

\_\_\_\_ \_\_\_\_ I will not take my parent's car without permission.

\_\_\_\_ \_\_\_\_ I will not allow anyone else to drive the car I have been allowed to drive, unless I have been given permission.

3. Abiding Rules of the Road

\_\_\_\_ \_\_\_\_ I will always keep my seatbelt fastened when I am driving or riding as a passenger. I will also require my passengers to wear their seatbelt when I am driving.

\_\_\_\_ \_\_\_\_ I will obey all traffic laws at all times.

\_\_\_\_ \_\_\_\_ I promise to never speed, for any reason.

4. Cell Phones & Other Distractions

\_\_\_\_ \_\_\_\_ I will not use my cell phone for any reason while driving. If I need to use my phone, I will pull off the road and park my car before doing so.

\_\_\_\_ \_\_\_\_ I will not allow any distracting or unsafe activity in my car when I am driving.

5. Alcohol & Drugs and Unsafe Situations

\_\_\_\_ \_\_\_\_ I promise to never drive if I am influenced by alcohol or drugs.

\_\_\_\_ \_\_\_\_ I promise to never ride with a driver who has consumed alcohol or drugs.

\_\_\_\_ \_\_\_\_ I will call my parent or find a safe ride if I am ever in any situation that compromises my safety.

6. Requirements
